- 14. Check the appropriate box(es). Check all the boxes that apply. If payment, specify nature.
- 15. Provide a specific and detailed description of the services that the lobbyists has performed, or will be expected to perform, and the date(s) of any services rendered. Include all preparatory and related activity, not just time spent in actual contact with Federal officials. Identify the Federal official(s) or employee(s) contracted or the officer(s), employee(s), or Member(s) of Congress that were contracted.
- 16. Check whether or not a SF-LLL-A Continuation sheet(s) is attached.
- 17. The certifying official shall sign and date the form, print his/her name, title, and telephone number.
