I. Introduction

Every two years, the Children, Youth and Families Department (CYFD) asks New Mexico child care providers what they charge to care for children. The information that is collected helps CYFD set reimbursement rates for child care providers.

Survey information was collected by the University of New Mexico, Division of Continuing Education's NewMexicoKids Child Care Resource & Referral, (505) 277-7900. Collected data was compiled and analyzed by Dr. Kate Krause, Associate Professor, Economics Department, 1915 Roma NE, Economics Building, Albuquerque, NM 87131-1101, (505) 277-3429; and Dennis Barber III, Statistical Analyst, PhD Student, University of New Mexico, Economics Department, (505) 277-2554.

A postcard was mailed to all licensed providers notifying them that the Market Rate Survey was going to take place and alerting them that they may be receiving as phone call from NewMexicoKids Child Care Resource & Referral (CCR&R). The script that was developed for the Survey referred to the postcard that providers should have received. Receipt of the postcard did not seem to be a factor as to their willingness to complete the survey.

Survey results were analyzed by age category, geographic stratification (metro or rural), and type of care (licensed centers, licensed group homes, licensed family homes and registered homes). Metro counties include Bernalillo, Doña Ana, Los Alamos, Sandoval, Santa Fe, San Juan, and Valencia. The State's remaining counties are rural. Age categories are defined as follows: Infant (Birth – 11 months, 1 yr – 1 yr 11 months), Toddler (2 yr – 2 yr 11 months), Preschool (3 yr – 3 yr 11 months, 4 yr – 4 yr 11 months, 5 yr – 5 yr 11 months), and School Age (6 – 12 years).

Data was also analyzed by STAR level; licensed childcare providers can participate in a 5-STAR level quality rating system, which allows for higher reimbursement rates to providers in correspondence with their star level. All licensed programs must be operating at 1-STAR (basic licensure) and reimbursement rates increase incrementally beginning at 2-STAR and continuing through 5-STAR (accreditation).

Tables were produced for the designated market segments (i.e. type of provider, age groups, geographic regions of the state and STAR level) including the mean, median, 75th percentile, minimum/maximum, the current CYFD rate, number of respondents, and the CYFD rate difference and percent difference from the mean and 75th percentile.

Providers were given the option of reporting monthly, weekly or daily full-time rates. Hourly rates were multiplied by 173.33, daily rates by 21.665 and weekly rates by 4.33 to establish monthly charges.

II. Methodology

The Market Rate Survey questionnaires for licensed and registered providers were developed by Nina Johnson, Program Manager, Early Childhood Services, Children, Youth and Families Department (CYFD) in conjunction with the UNM Division of Continuing Education staff and were reviewed by the Child Care Taskforce appointed by the Children, Youth and Families Department. The questionnaire (see Appendix B) included questions regarding demographic and environmental information; base childcare rates; special, extra or additional rates; and enrollment.

The methodology included attempting to survey all licensed providers accepting private paid fees with a response rate of 70-85% and a statistically valid sample of 200 from an estimated 1,130 non-relative registered home providers. Licensed providers that do not charge parents a market rate fee were eliminated from the population including Head Start programs, Tribal centers, and other

subsidized programs. This reduced the population of licensed center-based, family child care or family group home providers to 813. Surveys were completed with 665 providers or 81.79% of our target population. To ensure equal representation, data collection was organized by separating the providers by type and county. In several New Mexico counties, the few licensed programs are completely subsidized by either the federal, state, or city governments or grants and therefore were not included in the survey. Providers were called using contact information in the NewMexicoKids referral database or from lists provided by CYFD’s Child Care Services Bureau.

Only Registered homes that provide care for non-related children were included in the survey. The list was divided by county to assure that all possible counties were represented. After introducing themselves and stating the purpose of the call, the surveyors verified that the caregiver provided childcare for children who were not related to them. A total of 211 registered homes were successfully surveyed.

III. Response and Related Issues

Many attempts made to contact licensed and registered providers were unsuccessful for the reasons listed in the following chart. Attempts continued until the interview was completed or up to a maximum of ten (10) attempts had been made.

IV. Summary of Results

The first set of tables (tables 1 – 24) below present the market rates for licensed providers. The tables are organized by the following age groups: Infant (0 – 1 yr 11 months), Toddler (2 years – 2 years 11 months), Preschool (3 years – 5 years 11 months), School Age (6 years – 12 years). The disaggregated (Birth – 11 months, 1 yr – 1 yr 11 months, 2 yr – 2 yr 11 months, 3 yr – 3 yr 11 months, 4 yr – 4 yr 11 months, 5 yr – 5 yr 11 months, 6 – 12 years) statistical results are presented in Appendix A. Along with age groups, the tables are categorized by geographic location (metro or rural) and type-of-care category (licensed center, licensed family home or licensed group home). For example, the first table represents market rates for care for infants in metro centers. Within each table, the Star levels are represented across the columns. The rows present the CYFD reimbursement rate, the minimum and maximum rates that providers in each category charge, the mean (or average) rate that providers charge within each category, and the market rate at the median (50th percentile) and the 75th percentile.

Additionally depicted is CYFD's rate difference and percent difference from both the mean and the 75th percentile. Providers who do not charge for care were excluded from the analysis. The highest number of responses was received from metro centers. The data reflect an inverse correlation between mean market rate and age category. On the whole, the average rural market rate is lower than the average metro market rate and the average center market rate is higher than the family home market rate, which is higher than the group home market rate. The tables below outline the results of the Market Rate Survey. Accompanying each set of tables is an analysis of results disaggregated by type of care and age category. N/A indicates that no responses for the particular STAR level, age group, and home location/type were given or that there are no providers that fit into that particular category.

The second set of tables (tables 25 – 30) present aggregated data for the entire market and for care disaggregated by age groups only. The third set of tables (tables 31 – 42) present the market rates for registered providers. They give a statistical analysis, parallel to the data analysis of the licensed facilities, of the data collected from the responses from the registered facilities.

VI. Additional Analysis of Data

The primary focus of the survey was to determine rates for childcare in New Mexico.

However additional survey questions allow us to investigate three additional features of the industry: the extent to which care is available outside the normal working day, the extent to which caregivers maintain a wait list which is one measure of the adequacy of supply of childcare, and the factors that influence rate-setting by caregivers.

Hours of Operation

On average, childcare providers remain open for 11.6 hours per day, based on reported weekday hours. Far more caregivers are open early (before 7 a.m.) than are open late (after 7 p.m.). A small minority are open 24 hours a day. The availability of care at these hours varies by type of

care: centers are generally the least likely to offer extended-hour care. Average hours of care disaggregated by type of care, Star Level, and location are presented in Table 35.

Considerations in setting rates

Providers were asked about the factors that influence their rate determination. Because providers could give multiple answers, these are not expressed as percentages. Childcare rates in the community was named most often, with overall operating costs the second most common answer.

Parents’ willingness to pay, CYFD reimbursement rates and the cost of staff salaries and training were mentioned by more than one hundred providers, but fewer than mentioned the prevailing rates in the community or operating costs. Relatively few providers responded that they set their rates in order to earn their desired profit level or in response to the number of special needs children in their care.

VII. Observations and Lessons Learned

The amount of time it took to complete this project from start to finish was three months. One and a half months was devoted to planning and hiring student employees. Data collection was completed in one and a half months.

The increased use of caller ID may have reduced the number of answered phones, since the caller ID did not display “Children, Youth and Families Department”. Surveyors found that if a voice message was left that stated the purpose of the call, subsequent calls were more likely to be answered.

Many of the centers do not separate the children into the same age categories as the survey requested, thus extra time was spent while the staff tried to break down the ages in the requested categories. Examples of this are infants often went to 18 months and 4 and 5 year olds were often grouped together.

Surveying the registered homes was complicated by a lack of information. For future surveys, it would be helpful to know if a home only cares for extended family members, is on the Child and

Adult Care Food Plan but only cares for adults, or is monolingual Spanish. Both the licensed and registered list provided should reflect the most current and updated information on providers.

The time of year the survey is conducted is also of primary concern. The surveys were conducted in late February through March when most public schools close for Spring Break. While most of the centers stayed open, those connected with a school were closed. It also may have played a factor in reaching home care providers. Many seemed to take this time off presumably because they had their own school age children home.

Recommendations for future surveys include a three-step process. First, a postcard is sent to the identified, appropriate licensed and registered providers requesting that they go to a designated website and complete the Market Rate Survey. Three weeks later, a mail-in survey would be sent to providers who did not complete the survey online. After an additional three weeks, providers who did not complete the survey by mail or online would be called in person and their information documented by the surveyor.

Other suggestions include considering the possibility of including the Market Rate Survey information on the child care licensing application for initial licensing and for annual renewals. Then only those whose information is more than six months old would have to be contacted.
